**PAIFUP was shocked to learn that York County Prison, the largest ICE detention center in the state, will no longer house ICE detainees.** Our hope is that many individuals will get released instead of transferred, but ICE has already started transferring many out of state. We have been working alongside community partners to advocate for the release of the immigrants that remain. Learn how you can get involved below!

Our focus now is on creating a pathway forward since most of our clients were held at York County Prison. **We are optimistic about our future as we secured additional funding from the city of Philadelphia for next year.** We are honored to have the capacity to work alongside more immigrants.

## Client Success: Paul



Paul is a 66-year old man who came to the United States on a work visa from Jamaica in 1977 to join his mother and stepfather. He has lived in Philadelphia for over 40 years, and is a staple in his community—mentoring kids and helping his neighbors as a handyman. His mother filed an I-130 family-based petition for him, which was approved in 1980, but Paul did not have the funds to apply to adjust his status to that of a lawful permanent resident and so an Immigration Judge found his application

had been abandoned and ordered him deported.

After many years, Paul was able to reopen his case, and PAIFUP began representing him and helped him to file an application for adjustment of status. After many motions, ICE detention, appeals, rescheduled hearings, and a very lengthy court hearing, Paul was granted adjustment of status in April 2021 and received his green card in June 2021. He is now a lawful permanent resident, 44 years after coming to the United States. Paul wept tears of joy and relief as the judge gave the decision granting his case, with his PAIFUP attorney by his side. Paul told his PAIFUP attorney that he finally felt free and that without our help he didn't think he would have had the will to persevere through this process. He said, "You are just the best." Paul hopes to marry his long-term partner and move to Florida with her and his elderly mother. He now feels free from the burden of deportation hanging over his head for over 40 years.
