## Client Success: Eddie

Eddie is a Lawful Permanent Resident who has lived in the United States since 2008. His spouse, mother, and eight-year-old are all U.S. citizens.

He was detained by ICE in March 2020 at Clinton County Correctional Facility at the height of the COVID-19 pandemic. His family could not afford an attorney and they were desperate for help, worried about him getting infected.

PAIFUP attorneys took on Eddie's case and began representing him in April 2020. Eddie feared returning to the Dominican Republic, believing he would be murdered. His PAIFUP attorneys filed an application under the Convention Against

Torture, arguing that Eddie would suffer torture if he was sent back to the Dominican Republic. He had his individual merits hearing in July 2020, but the Immigration Judge denied his case. His PAIFUP attorneys quickly appealed that decision to the Board of Immigration Appeals. In doing so, his legal team pointed out errors in the Immigration Judge's decision and the Judge's failure to consider compelling evidence that Eddie could be killed if sent back.

While his case was pending before the BIA, there was a COVID-19 outbreak in the prison. He suffers from asthma and became very afraid. Eddie was infected and spent many weeks recovering. Shortly after, Eddie was transferred to another facility in Pennsylvania. At the same time, Eddie's lawyers got the news that the BIA agreed with their arguments on appeal, and so they sent Eddie's case back to the Immigration Judge to fix the errors.



Eddie's lawyers kept fighting for him, arguing to the Immigration Judge that his case should be granted, and in February 2021, the Immigration Judge granted Eddie's case, stopping his deportation. ICE continued to hold Eddie for 90 days but finally released him in May 2021 to his family.

Eddie surprised his son when he got home from school, tears running down both of their cheeks. He was greeted at his family home by his mother, his wife, cousins, aunts, and uncles, as well as his dog, who immediately recognized him as if he had never left. Eddie credits his PAIFUP lawyers for saving his life and allowing him to return to his family. His mother considers his PAIFUP attorneys "part of our family" and says she had no words for everything we have done for Eddie. "We are so happy and emotional. Thank you, a million times, thank you."
