

What's Happening?

PAIFUP had 2 clients released from detention thanks to the efforts of PAIFUP legal services and community organizations!

Check out two harrowing client success story below, along with articles from among the PA immigrant community.

Client Success: E

EP was living a version of the American dream. EP's father sponsored him to come from Haiti and obtain his green card. He moved his family to New York, where he was able to obtain a good job making purchases for a medical lab. After the attacks of September 11, EP felt it necessary to move his family from away NY to Philadelphia. He kept working hard, while helping to build a church and become a respected Deacon in his community. EP and his wife raised four successful adult daughters. But his dream quickly came to a nightmare, when a troubled teenager who he knew from birth and considered like a daughter accused him of sex crimes. He was referred to the innocence project after being convicted by a jury.

At the time EP left Haiti in 1999, he lived in a pleasant neighborhood outside of Port-au-Prince. What had been a safe neighborhood is now the sight of frequent gang attacks and kidnappings. EP had no enemies. But with help from PAIFUP attorneys, an expert witness help to explain to the removal court that because of EP's "Americanization" and criminal history, he would become a target for kidnappers. The immigration court granted EP protection from removal to Haiti under the United Nations Convention Against Torture. EP's wife and daughters, who stood by him through his American nightmare, now take some solace that they won't be separated from the person they admire most.

Client Success: J

After over 14 months of detention, Mr. J was granted protection under the convention against torture and released from ICE custody in November 2023, returning to the Philadelphia area and the place he has called home for over 20 years.

Mr. J was kidnapped by a rebel group at the age of 6, tortured by warlords, and made to witness atrocities, many committed by individuals who would later become powerful political figures in his native Liberia. After six years of enduring this trauma, he fled from Liberia to a refugee camp in Ghana before he and his family were ultimately resettled in Philadelphia in 2003. When he and his family came to the United States, he was a teenager, still suffering from that trauma. In 2008, he was placed into proceedings before an immigration judge, where he faced the threat of deportation. At the time, Pennsylvania did not provide any *pro bono* legal services to individuals in detention, and he was forced to represent himself, testify at length about the torture he had experienced in a language he did not speak fluently, and proceed without an assessment of how trauma affected his ability to participate in his case. He was ordered deported. However, he was released after six months in detention to reside and work in the U.S. while the government attempted to secure travel documents for him to return to Liberia. He continued building his life in Philadelphia, attending his immigration check-ins, working in delivery and food service jobs, and starting a family.

Then, in 2022, he was abruptly detained once again and told he would be deported. This came due to a change in U.S. relations with Liberia that caused Liberia to issue travel documents for Liberians, including those with very old deportation orders. Mr. J was terrified to return to Liberia. Upon detention and under the threat of deportation, he began to suffer a mental health crisis, and was diagnosed with schizophrenia spectrum and other psychotic disorder. Under threat of imminent deportation, his PAIFUP lawyer acted quickly to attempt to reopen his case and stop his deportation. He met his PAIFUP counsel a few days before Christmas in 2022, two weeks before the government planned to deport him. His lawyer worked throughout the holidays to stop his deportation right before he was placed on a plane, filing a stay of removal and a motion asking an immigration judge to reopen his case in light of the serious due process violations that occurred at his prior hearing and his eligibility for relief. The judge agreed that his case should be reopened in February 2023, and he was ultimately afforded a full and fair process before the Immigration Court, first at a competency hearing, where he was represented by counsel and had the benefit of a psychological evaluator to discuss his trauma affected his ability to testify and proceed in his case. At his final merits hearing, an IJ granted him relief from deportation. Though the government waived appeal of this decision, ICE refused to release Mr. J for over two months after his grant of relief. After intervention from his counsel, Mr. J was ultimately released in November 2023 to return home.

Mr. J is grateful to the PAIFUP program for giving him a second chance at life. He hopes to share his story through a book he began writing about his life while in detention and through motivational speaking about overcoming ones traumas and seeing the light through the darkness. He credits his PAIFUP team as having taught him "that there is sunshine in the dark," and he hopes to help others by sharing his story, to show them that they should not be "afraid to come out of the dark and into the light." After he was released, he told his PAIFUP attorney, "I am so grateful to be alive and breathing."
